Chapter "Putting Good Things on the Ground"

Sixteen selected local and international projects communicate options for action and new approaches to dealing with land. These examples show that spatial and urban development does not have to bow to the dictates of capital and the exploitation of resources and labor. They demonstrate that with initiative and courage, change is possible "from below," as well as "from above." The issue of "Land for Us All" is present in its ecological, economic and social dimensions, mostly multi-dimensionally.

Liberating the Land

Verein Bodenfreiheit (The Land Freedom Association)

In Vorarlberg, the discontent with the increasing development of important green spaces led to an amalgamation of like-minded people who are using highly innovative means to fight to keep the land free.

A Radical Dealing with City Highways from the 1970s Two Examples from Seoul

In 2002, the capital of South Korea decided to demolish an almost 6-km-long urban highway without replacing it and to expose the river below.

10 years later, the Skygarden project followed, which transformed a 1 km-long section of the city highway into a park-like pedestrian bridge.

Redensification of "Unter der Bahn"

If space is very limited, as in Vorarlberg, new ideas are needed. Nicole Rodlsberger and Johannes Sebastian Vilanek wrote their master's thesis on the redensification of an existing single-family housing estate in Götzis. Their proposals could serve as models for many comparable locations throughout Austria.

Land Initiatives in Basel

Against the background of the sell-off of urban land and rising housing prices in Basel, the population put an end to land sales by the Canton of Basel-Stadt in 2016.

After years of searching, the initiators of SchloR – a group of 18 very diverse people – found what they were looking for in Simmering and bought a 3,100 m2 former circus training area directly on the Eastern Railway line in summer 2019. It is now being converted into a self-managed cultural, workshop and residential project.

Chapter "Other Countries, Other Customs"

How do European neighbors feel about the land issue? Which different strategies are there for comparable challenges? System comparisons between countries are always difficult. Diverse legal systems and political cultures, but also historically evolved images of society and cultural peculiarities provide many variables. Nevertheless, comparative representations are inspiring in that they expand the spectrum of conceptual spaces and opportunities for action. The following six comparisons between Austria and one other European country each take a look at central issues of the land question.

Let's talk about the constitution, baby!

The constitutions of the states provide an insight into ideological differences that subsequently have a major impact on societal development. While the German Basic Law, for example, ties property to social obligation, property is particularly strongly protected in Austria.

Soil Protection and Food Security — Not Only in Times of Covid-19

The agricultural yield of a country depends on the availability of land, as well as on factors such as the fertility of the soil, the access to water or the production methods employed. So how are countries like Switzerland or Austria ensuring a sufficient supply of food for now and in the future?

Participation Needs Transparency

The Danish "Localplan" and the Austrian "Flächenwidmungsplan" (Zoning Plan). A key step towards transparency and participation is to ensure that public plans are available and understandable for the general public. Denmark plays a pioneering role in this respect.

How Social Is Socially Equitable Land Use?

Socially equitable land use in Munich, and dedicated areas for subsidised housing in Vienna. A comparative analysis of different planning measures that guarantee affordable housing in Munich and in Vienna despite steep rises in land prices.

Developing Building Land Instead of Hoarding It!

How are the challenges of urban sprawl and the hoarding of building land dealt with in South Tyrol and Tyrol? The comparison shows the difference between one coordinated overall strategy and rather dispersed competencies. At the same time, it becomes clear that there is no one-size-fits-all solution.

Value Appreciation for All or for a Few?

A local tax on value appreciation in Basel and urban development contracts in Vienna How can privately accrued value be taxed fairly and transparently for the general public when it is the product of municipal planning measures, such as rezoning or increasing the permitted building volume?
